Recognition Program

Purpose

The National Farm-City Council recognizes various organizations, businesses, groups and individuals for their outstanding work in accomplishing the mission of Farm-City: *to strengthen understanding of the farm-city connections that provide our food, fiber and shelter.*

Forms of Recognition

The National Farm-City Council provides:

- National Recognition Plaques: A maximum of two plaques can be awarded, per state, on an annual basis to be presented for outstanding events/activities in the state. The nominations must come from the state Farm-City contact to the National Farm-City Council.
- State Recognition Certificates: Recognition certificates can be presented by the state Farm-City committees to organizations, businesses, groups or individuals for exemplary work on Farm-City programs. There are no limits on the number of recognition certificates that can be awarded.

Criteria

Farm-City award recipients are recognized for:

- Program activities that support the mission of Farm-City.
- Program leadership that tells the story of agriculture to the urban public.
- Active communications in telling the story of rural-urban interdependence in our food and fiber system.
- Program efforts that bring rural and urban people closer together and foster a greater understanding among them.

Process

Nominations can be made by Council members, state contact persons or committees, organizations, businesses or others active in Farm-City programs. Nominations are to be submitted to the individual state contacts for consideration. The state contact will then submit the nominations to the National Farm-City Council for approval by the awards committee. The plaques and/or certificates will then be prepared and sent as requested by the state contact. Please allow three to four weeks for delivery.

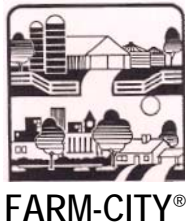

When Recognition is Due



There is no limit to the number of **State Recognition Certificates** that can be issued on an annual basis. These 8 1/2" X 11" certificates can be used to honor individuals, organizations, or governmental bodies. Allow 3-4 weeks for delivery from the National Farm-City Council. Each certificate or plaque is signed by the Chairman of the National Farm-City Council.

There is a limit of two **National Award** plaques per state per year. These certificates are mounted on a hardwood plaque with a clear acrylic face. These can be used to honor individuals, organizations, or governmental bodies. Allow 3-4 weeks for delivery from the National Farm-City Council.
